

**FORT WORTH STOCK SHOW SYNDICATE**  
**2024 SMOKEDOWN GIVEAWAYS**  
**OFFICIAL RULES**

**1. NO PURCHASE NECESSARY TO ENTER OR WIN.**

2. **HOW TO ENTER:** Beginning on March 20, 2024, through April 9, 2024, on Instagram, navigate to the Fort Worth Stock Show Syndicate's 2024 Smokedown Giveaways posts at @syndicatesmokedown and follow the online entry instructions. Provide all required information. You may return to @syndicatesmokedown to enter during each day of the sweepstakes; however, no more than one entry per day per Instagram account is permitted. Use of any robotic, automatic, programmed, or similar entry method or entering more than the number of times permitted will void all such entries and result in disqualification. You may not enter more times than indicated by using multiple Instagram accounts, identities, or devices in an attempt to circumvent the rules.

3. **ELIGIBILITY:** Open to Texas residents only who are 18 years of age and older as of the applicable date of the sweepstakes, except for members of the Fort Worth Stock Show Syndicate, a Texas nonprofit (501(c)(3)) corporation ("**Sponsor**"), and members of their immediate family or persons living in the same household. 4. **DRAWING:** A random drawing will be conducted on each date of the sweepstakes by the Sponsor to select the winner for each date from among all eligible entries received. Odds of winning depend on the number of entries received. Potential winners will be notified by email, phone, or Instagram direct message and must sign and return any required affidavit of eligibility and release within ten (10) days of the date notice is sent or such other date set by Sponsor. Failure to respond within the applicable time period will result in forfeiture of prize and Sponsor shall have the option to award the prize to an alternate winner. The return of any prize notification or prize as undeliverable may result in disqualification and an alternate winner may be selected. All income taxes resulting from acceptance of prize are the responsibility of winner.
